In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village– **Tala Ambapadar** under Thuamul Rampur Tahasil in the District of Kalahandi mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the proposed permission for use of 5.782 ha of forest land within total PL area of 153.571 ha in PL Block No. II (Chromite) Ore located in Village Kaliapani and Forest Block No.27 under Sukinda Tahasil of Jajpur District (within Jurisdiction of Cuttack Forest Division), Odisha for undertaking exploratory drilling of 95 no. of boreholes (95 boreholes @0.02ha each totaling 1.90ha and 3.882ha for construction of road) by M/s Odisha Mining Corporation Ltd vide in-principle approval order No.8-50/2018-FC dtd.14.09.2018 of Government of India, Ministry of Environment, Forests & Climate Change under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 3.882ha (9.600 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as **"Tala Ambapadar (D) Protected Forest**".
