S. R. O. No. 367/2018—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Kandulguda under Thuamul Rampur Tahasil in the district of Kalahandi mutated and transferred in favour of F. & E. Department for raising Compensatory Afforestation thereon against the proposed diversion of forest land for mining and ancillary activities pertaining to Tiringpahar Iron Ore Mines of O.M.C. Ltd. in Keonjhar District vide Stage-I Approval Order No. 8-54/2010-FC, dated the 27th Septemebr 2017 of Government of India, Ministry of Environment, Forests & Climate Change under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 9.222 ha. (22.79 acres) shall be Protected Forests with effect from the date of issue of the Notification and shall be known as Kandulguda Protected Forest :—
