NOTIFICATION

S. R. O. No. 584/2022—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village-Badbahal under Kishorenagar Tahasil in the district of Angul mutated and transferred in favour of Forest, Environment & Climate Change department for the purpose of raising Compensatory Afforestation thereon against the proposed diversion of 66.20 ha of forest land (including safety zone area of 1.899 ha) under Section-2 (ii) of the Forest (Conservation) Act, 1980 in respect of Jindal Chromite Mines of M/s Jindal Stainless Limited in village Kaliapani and Forest Block No. 27 of Mahagiri DPF in Sukinda Tahasil of Jajpur District under Cuttack Forest Division vide in-principle approval order of Government of India, Ministry of Environment, Forests & Climate Change, New Delhi communicated in Letter File No.8-68/2000-FC(pt.), on the 29th March 2022, the limits of which are specified below and the area of which is 9.029 ha (22.311 Ac.) shall be protected forest with effect from the date of issue of the Notification and shall be known as “Badbahal Protected Forest”.
