ORDER

The 11th August 2016

No. 4532—I-TTS-69/2016-SDTE—In exercise of power conferred under Section 3 (2) of the Odisha Professional Educational Institutions (Regulation of Admission and Fixation of Fee) Amendment Act, 2016, Government have been pleased to prescribe the following modalities for filling up of the vacant seats at College level with the qualified eligible candidates after vacancy round of OJEE Counselling :

1. The admission at Professional Educational Institution (hereinafter referred as institute) level shall be strictly done on merit basis in a fair and transparent manner. The candidates of the JEE (Main) 2016 will be preferred first followed by rank holders candidates of the 2nd OJEE.
2. The following categories of candidates are allowed for institute level admission against the vacant seats as declared by OJEE :
 - (i) The candidates, who have not participated earlier in two rounds of OJEE Counselling
 - (ii) The candidates who have participated in earlier two rounds of OJEE Counselling but not got allotment of seats.
 - (iii) Candidates, who have been allotted seats in earlier two rounds of Counselling but not reported at the allotted institute. (In this regard, the concerned institute should submit non-reported candidates list to the OJEE or before the 14th August 2016 which will be duly verified by the OJEE Committee).
 - (iv) The candidates, who have withdrawn after temporary allotment.
3. The Institute shall conduct Counselling of JEE Main 2016/OJEE 2016/GATE/GPAT/CAT/MAT/XAT/ATMA/CMAT/NIMCET/NATIONAL APTITUDE TEST in ARCHITECTURE (as the case may be) rank holder candidates and shall furnish the documents of eligible reported candidates to OJEE Committee, 2016 in support of the admission in respective institute. Candidates found ineligible (as per criteria indicated in Counselling Brochure of OJEE 2016) during the document verification will be debarred from admission.

4. List of students, admitted by the institutes should be submitted to OJEE by mail id : **odishajee2015@gmail.com** before the 15th August 2016 positively duly signed and authenticated by the concerned Principal on each page of the list. In no case hard copy of the list shall be entertained. Any list of the students beyond the said deadline of 15th August 2016 shall not be considered at any point of time.
5. The detailed guidelines for admission to the aforesaid courses are given in the Counselling Brochure of OJEE, 2016.
6. The Principals of the institutes, who are making admission at institute level, are requested to verify the documents of the candidate duly and confirm that these admissions are as per the norms/guidelines/rules prescribed by the Government /OJEE. They shall submit a duly signed affidavit to that effect to OJEE while submitting documents for verification.
7. For any clarification, if so necessary, the decision of the Government in Skill Development & Technical Education Department shall be final and binding.
