S.R.O. No. 213/2023—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Bali under Banspal Tahasil in the district of Keonjhar mutated and transferred in favour of Forest, Environment & Climate Change Department for raising Compensatory Afforestation thereon against the pre-1980 broken up forest land, i.e. over 94.895 ha within Nuagaon Iron Ore Mines of M/s JSW Steel Ltd. under Barbil Tahasil of Keonjhar District, Odisha vide diversion of 476.205 ha (371.192 ha approved) of forest land for mining or Iron Ore within the mining lease area of 767.284 ha in village Guali, Nuagaon in Keonjhar, Odisha by Government of India, MoE&F (FC Division), New Delhi communicated in Letter No. 8-17/2021-FC, dated the 22nd April 2004 under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 94.9610 ha (234.6501 Ac) shall be Protected Forest with effect from the date of issue of the Notification and shall be known as "Bali Protected Forest".
