NOTIFICATION

S. R. O. No. 126/2016—Whereas, the State Government have authorized the carrying out of Seaward Artillery Practice from the 30th July 2013 in the notification of the Government of Odisha in the Home (Special Section) Department No.1896-C., dated the 30th July 2013 published in the extraordinary issue of the *Odisha Gazette* No.1483, dated the 31st July 2013 bearing S.R.O. No. 516/2013 over an area specified in the Schedule to the said notification ;

Whereas, in view of the operationalization of an all weather Port at Gopalpur and to provide anchorage area to the waiting ships, the existing Seaward Artillery Practice needs to be shifted southward of the Gopalpur Port ;

Now, therefore, in exercise of the powers conferred by sub-section (1) of Section 3 of the Seaward Artillery Practice Act, 1949 (8 of 1949) read with the notification of the Government of India in the Ministry of Defence (Navy Branch) No. S.R.O.1, dated the 9th January 1980 and in supersession of the said notification of the Government of Odisha in the Home (Special Section) Department, dated the 30th July 2013 the State Government do hereby authorize the carrying out of Seaward Artillery Practice over the area specified in Schedule below for a further period of 3 years commencing immediately after expiry of fourteen days from the date of publication of this notification in the *Odisha Gazette* till 13th April 2019.

SCHEDULE

The entire area over the land and water, covering 500 meters landwards, between North-Eastern Point, latitude 19° 14' 36" longitude 84° 53' 42" and South-Western Point, latitude 19° 12' 37" longitude 84° 51' 34" and seawards as bounded by the following lines :—

1. Line joining Point A (19° 14' .36" N, 084° 53' 42" E) and Point B (19° 7' 23.43" N, 085° 35' 56.19" E).
2. Line joining Point A (19° 14' 36" N, 084° 53' 42" E) and Point C (18° 33' 36.66" N, 084° 53' 44.68" E).
3. An arc joining Point B (19° 7' 23.43" N, 085° 35' 56.19" E) and Point C (18° 33' 36.66" N, 084° 53' 44.68" E) with a radius of 75 Kms. from the Centre Point A (19° 14' 36" N, 084° 53' 42" E) having an internal angle $\angle BAC 80^\circ$.
