No. 15398—WCD-CW-SCHM-0040/2015-WCD.—In pursuance of sub-sections (1) and (2) of Section 4 of the Juvenile Justice (Care and Protection of Children) Act, 2015, read with sub-rules (7) and (8) of the Rule 3 of the Juvenile Justice (Care and Protection of Children) Odisha Rules, 2002 and its amendment made in the year 2009, the Juvenile Justice Boards in the 28 districts viz.
