#### NOTIFICATION

The 17th November 2020

S.R.O. No. 245/2020—In exercise of the powers conferred under Section 33 of the Odisha Forest Act 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in Village Bhitarpadar under Thuamul Rampur Tahasil in the district of Kalahandi mutated and transferred in favour of Forest & Environment Department for the purpose of raising compensatory afforestation thereon against the permission accorded for use of 14.642 Ha. of forest land within total mining lease area of 936.22 Ha. (700.12 Ha. forest land + 236.10 Ha. nonforest land) in Kalarangi Chromite Mining Lease located in Sukinda Forest Range of Cuttack Forest Division in Jajpur District, Odisha for undertaking exploratory drilling of 214 No. of boreholes of 4" dia ( 134 No. of boreholes over 2.68 Ha. forest land and 80 No. of boreholes in non-forest land) and 11.962 Ha. of forest land for construction of road by M/s Odisha Mining Corporation Ltd. vide Final approval Order No. 8-16/2015-FC, dated the 8th May 2019 of Government of India, Ministry of Environment, Forests & Climate Change under Section 2 of the Forest (Conservation) Act, 1980, the limits of which are specified below and the area of which is 11.962 Ha. (29.56 acres), shall be Protected Forests with effect from the date of issue of the Notification and shall be known as "Bhitarpadar (B) Protected Forest".
