No. 11650—DAFE-AFE-FE-0131/2022-Ag.&F.E.—The following Block Agriculture Officers (BAO) / Assistant Directors of Agriculture (ADA) are promoted to the rank of Agriculture District Officer (ADO) / Deputy Director of Agriculture (DDA), on *ad hoc* basic in the Pay Scale of Level-13 of Pay Matrix under O.R.S.P. Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This *ad hoc* promotion is subject to concurrence of the OPSC on their earlier *ad hoc* promotion to the rank of BAO/ADA. If the OPSC do not agree to concur the earlier *ad hoc* promotion of any of the following officers, he will be reverted to the lower grade of the cader.
