#### **NOTIFICATION**

No. 15694—HFW-MEI-MISC-0059/2023-H.—In order to facilitate sports activities, cultural activities and other extra-curricular activities of the students pursuing Medical UG and PG studies at Government Medical College/PG Institute in the State, Government have been pleased to provide a Students' Welfare Fund for the above purpose to be placed with the Dean & Principal of each Government Medical College, the Director of AHPGIC, Cuttack and PGIMER and Capital Hospital, Bhubaneswar, the Superintendent, SVPPGIP, Cuttack, the Director-*cum*-Medical Superintendent, Mental Health Institute, Cuttack and the Principal, SCB Dental College, Cuttack in the following manner:—

List of recommended activities to be undertaken under the fund —

- (1) To support students' activities like physical training, sports and cultural activities.
- (2) To meet the cost towards outsourcing of part-time physical instructor/ yoga/ music teacher.
- (3) To support various intra-college and intra-institute musical, sports and cultural activities/ festivals undertaken by the students' bodies.
- (4) Purchase of sports/music/other equipment for extra-curricular students' activities.
- (5) To facilitate minor repair and maintenance of the playground/gym/other equipment used for student activities.
- (6) To facilitate celebration of important days bearing National and State importance by the students.
- (7) Provision of Gen-set / Power supply backup for student activities.
- (8) Purchase of plants & ancillary items/equipment for campus greening activities.
- (9) To support any other extra-curricular activities of students as decided by the College-level / Institute-level Committee.

List of prohibited activities not to be undertaken under the fund —

- (1) Hiring of full-time manpower.
- (2) Hiring/purchase of vehicle on long-term basis.

## 1. Amount of funds to be placed

Total Students' Welfare Fund amounting to Rs.20 lakh per annum will be provided to each Government Medical College which has completed 5 years, and total Students' Welfare Fund amounting to Rs. 15 lakh per annum will be provided to each Government Medical College which has not completed 5 years. In a similar manner, total Students' Welfare Fund amounting to Rs. 8 lakh each per annum will be provided to Government PG Institutes, SCB Dental College, Cuttack and Mental Health Institute, SCB Medical College & Hospital, Cuttack.

#### 2. Utilisation of fund

The Students' Welfare Fund to be placed with the Dean & Principal of each Government Medical College, Director of AHPGIC, Cuttack and PGIMER and Capital Hospital, Bhubaneswar, the Superintendent, SVPPGIP, Cuttack, the Director-*cum*-Medical Superintendent, Mental Health Institute, Cuttack and the Principal, SCB Dental College, Cuttack as lump sum budgetary provision to be utilised in the following manner:—

(1) Committee : A Committee shall be constituted for each Medical College and Hospital/Dental College /PG Institute for the purpose, as below —

(2) The Committee will finalize the works/activities to be funded out of the Students' Welfare Fund.

#### 3. Procedures for utilisation of Fund:—

- 1. The grants towards Students' Welfare Fund shall be kept in a separate Flexi Bank Account to be opened for this purpose as approved by the Chairperson.
- 2. The Chairperson of the Committee shall be the Chairperson of the fund. The Superintendent/the seniormost faculty other than the Chairperson shall be the Member-Secretary of the fund. The Accounts Officer of the MCH shall be the Treasurer of the fund. All expenditures shall be approved by the Chairperson.
- 3. Standard accounting procedures as prescribed by the Finance Department from time to time shall be followed.
- 4. Books of Account for the fund shall be a single Cash Book. But a separate Ledger Account to be maintained for different purposes, so that funds position can be easily accessed. All payments should be made through cheques/ online modes.
- 5. The Fund Account shall be maintained regularly and it should be opened to Audit by C. & A.G. and Internal Audit of H. & F.W. Department.
- 6. The proposal for utilization of the funds must be discussed and approved in the Committee.

### 4. Monitoring & Review

- 1. Utilisation of fund is to be monitored every month by the Chairperson.
- 2. Chairperson will review the outcome and take necessary remedial measures at 6 monthly intervals.
- 3. This outcome of the fund shall be reviewed annually by the DMET, Odisha and its outcome shall be assessed both in qualitative and quantitative terms.
