NOTIFICATION

S.R.O. No. 753/2023—In exercise of the powers conferred under Section 33 of the Odisha Forest Act, 1972 (Odisha Act 14 of 1972), the State Government do hereby declare that the following land situated in village Kapani under Belpada Tahasil in the district of Bolangir mutated and transferred in favour of Forest, Environment & Climate Change Department for the purpose of raising Compensatory Afforestation thereon against the proposed diversion of 341.23 ha of forest land in Bolangir Forest Division under Bolangir District, Odisha for construction of Upper Lanth Medium Irrigation Project vide inprinciple approval of Government of India, Ministry of Environment, Forests & Climate Change (FC Division), New Delhi communicated vide Letter F. No. 8-59/2018-FC, dated the 21st December 2018 & subsequent instruction of Government of India, Ministry of Environment, Forests & Climate Change (FC Division), New Delhi dated the 1st April 2020, the limits of which are specified below and the area of which is 27.203 ha (67.220 acres), shall be 'Protected Forest' with effect from the date of issue of the notification and shall be known as "Kapani Protected Forest" :—
