RESOLUTION

The 31st May 2023

The State Government in Department of Agriculture and Farmers' Empowerment have published the Guidelines on "Mukhyamantri Krushi Udyog Yojana" vide Notification No. 20984/A&FE dated 23.12.2020. For faster, easier and hassle-free implementation of the said Yojana, after careful consideration, the Government have been pleased to modify the aforesaid guidelines of MKUY as follows: -

- 1. In order to simplify the process of valuation of completed self-financed projects costing more than ₹.10 Lakhs the Para-P of the said Guidelines and Point No. 2 and 3 of this Department Resolution No. 4771 dtd. 10.03.2022 published vide Odisha Gazette no. 455 dtd. 16.03.2022 is modified to the extent given below:-
 - (a) The heading under Para-P.1 is modified as
 - "(i) Self-finance projects costing upto ₹.10 Lakh"
- (b) The following is inserted under Para-P.1:-
 - "(ii) Self-finance projects costing more than ₹. 10 Lakh Thevaluation of completed projects will be carried out by a team consisting of SE, Agril(Chairman), District Nodal Officer(DNO) of concerned sector(Convenor)/ in case of inter sectorial projects Chief District Agriculture Officer(CDAO) along with concerned sectorial DNO, Lead District Manager(LDM) and District Manager(DM), APICOL in the format at **Annexure-V**."
 - 2. So as to provide greater opportunity and encourage the agri-entrepreneurs, additional Capital Investment Subsidy(CIS) assistance under the Yojana is allowed to those who have already availed full limit of CIS and are continuing the projects.

Accordingly, the following paragraph is added after the last paragraph under Para-D of the Guidelines:-

"The CIS limit as specified under MKUY is marked for a trench of 10 years. After 10 years, a beneficiary/ family would be eligible for a fresh CIS limit upon executing new project(s) or expansion/up-gradation of existing units subject to successful completion and running of the earlier project(s) for at least 10 years. The date will be calculated from the date of availing full limit of CIS."

- 3. The sentence "Lease agreement to be considered from the date of application" is inserted in the Para-Q.1.b of the said Guidelines.
- 4. To obviate the difficulties faced by some farmers residing in the villages, the land records of which are not available in Bhulekh being unsurveyed villages, the following riding provision under Para-Q.1 is inserted:-
 - "d.The applicant shall be allowed to fill up the online application that the village comes under the un-surveyed village category and he/she will attach a Certificate from the Tahasildar that he/she is the inhabitant of that village and the village comes under the un-surveyed village category."
- 5. The following line is inserted after "online/cheques." under Para-O(9) of the said Guidelines:-

"Identification of seller is Mandatory(Photocopy of Aadhar Card of the seller to be attached) in case of hand written bill"

This shall come into force with effect from the date of publication of the Resolution in the Odisha Gazette.

ORDER—Ordered that the Resolution be published in the Extra-ordinary issue of the Odisha Gazette and copies thereof be forwarded to all the Departments of Government.
