No tender will be considered without a valid VAT Clearance Certificate in Form VAT- 612 in respect of the bidders of inside the State. The aforesaid original certificate may be produced at the time of execution of agreement for necessary verification and return. The bidders from the outside the State who have not been registered under the VAT Act and have not started any business in the State have to submit undertakings in the form of an affidavit as indicated in the Terms and conditions of the tender.

TERMS AND CONDITIONS OF THE TENDER

- (i) It is mandatory that all tender documents have to be signed at each page and annexed the tender.
- (ii) The tenderer shall be treated to have qualified in the technical bid if its sample conforms to the IS specifications, as per the EPM laboratory report and also after the testing of the samples by the Technical Testing Committee of the Directorate of P S & P.
- (iii) The price bid shall be opened only if the tenderer qualified in the technical bid.
- (iv) In case of procurement of 60 GSM Cream Wove Paper the brightness parameter should be 80% and for 70 GSM and 80 GSM Maplitho Paper the brightness parameter should be 88% to 90 %. The EPM Laboratory testing report conforming to the specified brightness parameter shall be accepted.
- (v) All columns of the Tender Paper should be duly filled in.
- (vi) Photo copy of up to date VAT clearance certificate in form VAT-612 and GST Registration Certificate copy must be enclosed by the bidder belonging to the State of Odisha.
- (vii) The bidders from outside the State of Odisha who have not been registered under the VAT Act and have not started any business in Odisha, may participate the tender without having any VAT clearance subject to condition that they shall have to submit an undertaking in the form of an affidavit indicating therein that they are not registered under VAT Act since they have no liability under the Act.The bidder of outside state shall furnished GST Registration Certificate copy in their tender paper.
- (viii) Photo copy of Income Tax and PAN card must be enclosed.
- (ix) The E.M.D. shall stand forfeit to Government in case the bidder fails to execute agreement with required security deposit or withdraws rates quoted within 15 days from the date of receipt of letter.
- (x) Transfer/Adjustment of deposits of E.M.D. towards deposit of Security Money shall not be permitted in any circumstances.
- (xi) The bidders shall have to give complete/detail break up of the price quoted wherever necessary, the price quoted should be in words and figures. Rates quoted should be inclusive of all taxes, freight etc. for free delivery in the Press premises. The bidders shall supply documentary evidence in case of escalation/de-escalation of Taxes or Duties such as Value Added Tax, Entry Tax, Central Sales Tax due to fiscal policy of the State or Central Government. The discretion to fix the price of goods/articles supplied rests with the Director, provided the supplier submits authentic documentary evidence.

- (xii) The bidder shall deposit required amount of earnest money along with the tender. The tender without earnest money shall not be accepted under any circumstances. Request for transfer of any previous deposit or adjustment of earnest money concerning of any claim payable shall not be entertained.
- (xiii) The bidders shall not be entitled any interest on the earnest money deposit, except what may be allowed and paid by the Bank/Postal Authorities and the unsuccessful bidders shall be refunded as early as possible.
- (xiv) The rate/price accepted shall remain valid till 31.3.2018.
- (xv) There should not be overwriting, addition, alteration and erasing on Tender Paper. All corrections, if any, on the tender paper should be duly signed by the bidder.
- (xvi) The tender paper purchased by a bidder cannot be transferred or sold to others. Only the purchaser of the tender paper can submit the tender.
- (xvii) One rate shall be offered for one item. Submission of multiple rates against one item will lead to non-consideration of the item. In case there are different brands to be offered against one item, all of them should confirm the standard specifications, in such cases the bidder can offer maximum three rates with separate samples.
- (xviii) No pre-condition pertaining to specification and quantity of the item shall be accepted.
- In the event of acceptance of rates the bidder shall have to execute agreement with security deposit to the amount of 5% to 10% as would be decided by the Director of the value of the article(s) to be supplied within the stipulated time as mentioned in the supply order. The deposit shall be made in the Postal Savings Bank Account/P.T.D./N.S.C. in the name of bidder pledged in the name of the Director, Printing, Stationery & Publication, Odisha, Cuttack-10. Scheduled Bank deposits should be made in the name of the Director, Printing, Stationery and Publication, Odisha, Cuttack. Security Money should remain valid for a period of sixty days beyond the date of completion of all contractual obligations.

In case of failure to deposit the security money and sign agreement in time, the firm may be blacklisted and the E.M.D. deposited for the specific items / article(s) for which the contract has been awarded may be forfeited as deemed necessary.

- (xx) In the event of breach of contract by the bidder, the entire security deposit money shall be forfeited.
- (xxi) The supply of the goods/materials shall be completed within the time specified.
- (xxii) Goods/articles supplied shall be received for taking weighment by using the weighbridge by the bidder at his own cost.
- (xxiii) Quantity of stock shall be accounted on the basis of weight of paper in sheets and reels.
- (xxiv) Packing/Markings shall have to be inconformity with I.S. specification. Each reel/ream. must have label revealing G.S.M., size, weight, no. of sheets (in case of sheet paper) and lot no. of the manufacturing firm.

- (xxv) The rates shall always be for net weight and measure and shall be inclusive of all charges of Packing, Container, etc.
- (xxvi) The testing charges of different varieties of paper items conducted by any Testing Laboratory either inside the State or outside the State shall have to be borne by the bidder. If the testing fee is not deposited by the bidder in due time, the same will be recovered from the E.M.D. furnished by the bidder.

Bidders eligible for exemption of earnest money deposits will have to deposit the provisional testing fees of the sample papers as would be intimated by this Directorate within 7 (seven) days from the date of issue of intimation in shape of Demand Draft from any Nationalized Bank duly pledged in favour of the Director, Printing, Stationery and Publication, Odisha, Madhupatna, Cuttack-10, otherwise their bids shall not be taken in to consideration and shall be rejected. Soon after receipt of the actual bill relating to testing fees of the paper sample from the Testing Laboratory, the actual amount of testing fees shall be intimated to the firm concerned for depositing the amount in this Directorate within 7 (seven) days of issue of intimation. On receipt of actual testing fees from the firm, the provisional testing fees deposited earlier will be released in favour of the firm concerned otherwise the deposited amount shall be forfeited to Govt.

- The supply shall conform to the approved sample, otherwise the stock supplied shall be returned or rejected without assigning any reason at his/her own cost. The supplied materials, if necessary, shall be subjected to Laboratory and Machine testing to be decided by the Director, PS&P, Cuttack. After such testing, if the supplied material does not conform to the required specifications, the entire security deposit or suitable percentage from the security deposit, as would be decided by the Director, Printing, Stationery and Publication, Odisha, Cuttack will be forfeited without assigning any reason thereof. The test report of the Laboratory shall be binding on the supplier / purchaser.
- (xxviii) The supplier will be responsible for the stock to reach the godown of the DPS&P in perfect condition.
- (xxix) The supplier at his own interest should obtain transit insurance coverage of the articles at his own expense.
- (xxx) Payment shall be made only on receipt of paper in perfect condition and quality as per specifications, etc. as mentioned in the terms and conditions of the Tender.
- (xxxi) The paper shall be acceptable if the actual weight vary from the nominal weight by 2.5% either way. If the actual weight is less than the nominal weight, then only the actual weight shall be paid for. In no circumstances, more than the nominal weight will be paid for.
- (xxxii) Correspondence should be made with the Director, Printing, Stationery & Publication, Odisha, Cuttack-753010 in his official address not by name.
- (xxxiii) All bills should be submitted to the consignee, duly stamped and pre-receipted on receipt of acceptance report of stock from the consignee(s) concerned. Original Excise Gate Pass shall be submitted along with the bills.

- (xxxiv) Preference will be given to the articles having I.S.I. Mark. In case I.S.I. Marked. articles are not available, preference will be given to the articles conforming I.S. specification.
- (xxxv) Director has the right to relax any or more conditions in the public interest as and when such circumstance arises.
- (xxxvi) The bidder is to sign and return the tender paper duly signed and sealed in token of their acceptance failing which the same may be ignored or rejected.
- (xxxvii) Tender should be in double sealed cover super scribed "Tender against Tender Notice No.02/PAPER/ 2017- 18".
 - (a) First sealed cover will contain all tender documents including technical bid and excluding the rates of the items.
 - (b) Second sealed cover will contain the price bid covering the rates of the items.
