Details of tender documents can be obtained on any working day during the office hour from **23.11.2019 to 13.12.2019** in between 11.00 A.M. to 4.00 P.M. from the Purchase Section of this Directorate on payment of **Rs.1,515/- (Rupees one thousand five hundred fifteen)** only including tax (non-refundable) in cash only.

The tender documents can also be down loaded from Odisha Government Website i.e. www.odisha.gov.nic.in/www.ogpress.nic.in. In such cases the tender is to be submitted along with a bank draft of **Rs.1,515/- (Rupees one thousand five hundred fifteen)** only including tax (non-refundable) drawn in favour of Director, Printing, Stationery & Publication, Odisha, Cuttack.

The tender documents, as required by this office along with samples, Earnest Money Deposits and testing fees of sample(s) in prescribed manner, shall be received up to **16.12.2019 by 11.00 A.M.** and the technical bids shall be opened on the same day at 3.00 P.M. in presence of the tenderers or their authorised representatives.

Tender shall be finalised by the Authority.

The undersigned reserves the right to reject any or all tenders and to alter/amend the terms and conditions of tender without assigning any reason thereof.

DOCUMENTS TO BE ATTACHED ALONG WITH THE TENDERS

1. Copies of latest return in Form GSTR-3B and GSTR-1 downloaded from GSTN Portal along with copy of valid registration Certificate in Form GST REG-25 shall be submitted. Without such documents in respect of the bidders, no tender will be considered. The aforesaid original certificate may be produced at the time of execution of agreement for due verification, if required.
2. Photo copy of Income Tax PAN Card must be enclosed.
3. Statement of Information duly filled-in (in duplicate) as per the Proforma enclosed.
4. S.S.I. Certificate from the Director of Industries/Certificate of rate contract from Director of E.P.M.of the State of Odisha,/Certificate of registration of M.S.M.E. issued by the Competent Authority, if any.
- 5. Earnest Money Deposits @ 5 % of the highest tendered value of paper items to be furnished in shape of Postal savings Bank Accounts/P.O.T.D./ National Savings Certificate in the name of the bidder duly pledged in favour of the Director, Printing, Stationery & Publication, Odisha, Cuttack/Deposit Receipt of any Scheduled Banks (except Bank Draft & Cheque) duly pledged in the name of the Director, Printing, Stationery & Publication, Odisha, Cuttack. Earnest Money Deposit is normally to remain valid for a period of forty-five days beyond the final bid validity period. Tenders without Earnest Money Deposit will not be considered under any circumstances.**
6. Fifty full sheets of paper of 42 Cms. X 59.4 Cms. i.e. A-2 size without fold for each variety/colour of paper for which rates quoted should be supplied along with the tender to use as samples for testing in the Laboratory. The cost of the sample paper shall not be paid. The bidder will also be required to submit the samples in shape of reels/reams free of cost for machine test on intimation. Each sample sheet should contain the following particulars in the top right hand corner.
 - (a) Seal with signature of the firm with name and address of the Bidder.
 - (b) Seal with signature of the Manufacturer on behalf of whom sample furnished (in case of other than Manufacturer).
 - (c) Item number of specific parts & specification of paper.
 - (d) Name of the Manufacturer giving authorisation (in case of other than Manufacturer).
- 7. Testing charges for each sample of paper item as per the tariff rate of E.P.M. Testing laboratory ,Cuttack attached as Annexure –A shall be furnished in shape of Demand Draft from any nationalized bank payable in favour of Senior Scientific Officer, E.P.M. Testing laboratory, Cuttack. Tenders without /less payment of testing charges will not be considered under any circumstance.**
8. Authorisation from the Manufacturer, if the bidder is an authorised Distributor/Agent.
9. A detailed list of samples against quoted rates for the item clearly written/typed in triplicate otherwise is liable for rejection.
10. Specimen signatures (in quadruplicate) of the authorised person(s) on behalf of the bidder duly attested by the bidder.

TERMS AND CONDITIONS OF THE TENDER

- (i) It is mandatory that all tender documents have to be signed by the bidder in each page and , indexed ,annexed to the tender.
- (ii) The tender shall be treated to have qualified in the technical bid if its sample conforms to the IS specifications, as per the EPM laboratory report and also after the testing of the samples by the Technical Committee of the Directorate of P S & P.
- (iii) The price bid shall be opened only if the tender qualified in the technical bid.
- (iv) In case of procurement of 70 GSM Maplitho Paper(Natural Shade),80 GSM Maplitho Paper Natural Shade, 90 GSM Maplitho Paper Natural Shade, 120 GSM Maplitho Paper and 160 GSM Art Paper(Matt), the brightness parameter should be 88% to 90 %. The EPM Laboratory testing report conforming to the specified brightness parameter shall be accepted .
- (v) All columns of the Tender Paper should be duly filled in.
- (vi) Photo copy of valid GST Registration Certificate must be enclosed by the bidder. Copy of latest filed GST returns in form GSTR-1 and GSTR-3B are to be furnished.
- (vii) Photo copy of Income Tax , PAN card must be enclosed.
- (viii) The E.M.D. shall stand forfeited to Government in case the bidder fails to execute agreement with required security deposit or withdraws rates quoted within 15 days from the date of receipt of letter in this regards.
- (ix) Transfer/Adjustment of deposits of E.M.D. towards deposit of Security Money shall not be permitted in any circumstances.
- (x) The bidders shall have to give complete/detail break up of the price quoted wherever necessary, the price quoted should be in words and figures. Rates quoted should be exclusive of GST but inclusive of all other taxes if applicable under any law, freight etc., for free delivery in the Press premises. The discretion to fix the price of goods/articles supplied rests with the Director P.S & P, Cuttack, provided the supplier submits authentic documentary evidence.

- (xi) The bidder shall deposit required amount of earnest money along with the tender. The tender without earnest money shall not be accepted under any circumstances. Request for transfer of any previous deposit or adjustment of earnest money concerning of any claim payable shall not be entertained.
- (xii) The bidders shall not be entitled any interest on the earnest money deposit, except what may be allowed and paid by the Bank/Postal Authorities. E.M.D. of unsuccessful bidders shall be refunded as early as possible.
- (xiii) The rate/price accepted shall remain valid till **31.3.2020**.
- (xiv) There should not be overwriting, addition, alteration and erasing on Tender Paper. All corrections, if any, on the tender paper shall be duly attested by the bidder with signature.
- (xv) The tender paper purchased by a bidder cannot be transferred or sold to others. Only the purchaser of the tender paper can submit the tender.
- (xvi) One rate shall be offered for one item. Submission of multiple rates against one item will lead to non-consideration of the item. In case there are different brands to be offered against one item, all of them should be with conformation of the standard specifications and in such cases the bidder can offer maximum two samples with their rates.
- (xvii) No pre-condition pertaining to specification and quantity of the item shall be accepted.
- (xviii) In the event of acceptance of rates the bidder shall have to execute agreement with security deposit to the amount of 5% to 10% as would be decided by the Director, P.S & P,Cuttack of the value of the article(s) to be supplied within the stipulated time as mentioned in the supply order. The deposit shall be made in the Postal Savings Bank Account/P.T.D./N.S.C. in the name of bidder and must be pledged in the name of the Director, Printing, Stationery & Publication, Odisha, Cuttack-10. Scheduled Bank deposits should be made in the name of the Director, Printing, Stationery & Publication, Odisha, Cuttack. Security Money should remain valid for a period of sixty days beyond the date of completion of all contractual obligations.

In case of failure to deposit the security money and sign agreement in time by successful bidder, the firm may be blacklisted and the E.M.D. deposited for the specific items / article(s) for which the contract has been awarded may be forfeited as deemed necessary.
- (xix) In the event of breach of contract by the bidder, the entire security deposit money shall be forfeited.
- (xx) The supply of the goods/materials shall be completed within the time specified.
- (xxi) Goods/articles supplied shall be received after taking weighment in presence of authorized Departmental Officer by using the weighbridge by the bidder at his own cost.
- (xxii) Quantity of stock shall be accounted on the basis of weight of paper in sheets and reels.
- (xxiii) Packing/Markings shall have to be in conformity with I.S. specification. Each reel/ream. must have labelled revealing G.S.M., size, weight, no. of sheets (in case of sheet paper) and lot no. of the manufacturing firm.

- (xxiv) The rates shall always be for net weight and measure and shall be inclusive of all charges of Packing, Container, etc.
- (xxv) Testing charges of different paper items conducted by any Testing Laboratory either inside the state or outside the State shall have to be borne by the bidder even if eligible for exemption of earnest money deposit. In the event of any change in rate of tariff of Testing Charges or request for any subsequent testing, if considered by the Director, the differential amount or the whole amount of charges of subsequent testing as the case may be, shall be deposited by the bidder in due time as directed, and failure to deposit such amount by the bidder, the same will be recovered from the E.M.D. furnished by the bidder.
Demand draft furnished against Testing Charges by the bidder who has not qualified on evaluation of technical bid will be returned to the bidder.
- (xxvi) The supply shall conform to the approved sample, otherwise the stock supplied shall be returned or rejected without assigning any reason at his/her own cost. The supplied materials, if necessary, shall be subjected to Laboratory and Machine testing if decided by the Director, PS&P, Cuttack. After such testing, if the supplied material does not conform to the required specifications, the entire security deposit or suitable percentage from the security deposit, as would be decided by the Director, Printing, Stationery & Publication, Odisha, Cuttack will be forfeited without assigning any reason thereof. The test report of the Laboratory shall be binding on the supplier / purchaser.
- (xxvii) The supplier will be responsible for the stock to reach the godown of the DPS&P in perfect condition.
- (xxviii) The supplier at his own interest should obtain transit insurance coverage of the articles at his own expense.
- (xxix) Payment shall be made only on receipt of paper in perfect condition and quality as per specifications, etc. as mentioned in the terms and conditions of the Tender.
- (xxx) The paper shall be acceptable if the actual weight vary from the nominal weight by 2.5% either way. If the actual weight is less than the nominal weight, then only the actual weight shall be paid for. In no circumstances, more than the nominal weight will be paid for.
- (xxxi) Correspondence should be made with the Director, Printing, Stationery & Publication, Odisha, Cuttack-753010 in his official address not by name.
- (xxxii) All bills should be submitted to the consignee, duly stamped and pre-receipted on receipt of acceptance report of stock from the consignee(s) concerned. Original Excise Gate Pass shall be submitted along with the bills.

- (xxxiii) Preference will be given to the articles having I.S.I. Mark. In case I.S.I. Marked. articles are not available, preference will be given to the articles conforming I.S. specification.
- (xxxiv) Director has the right to relax any or more conditions in the public interest as and when such circumstance arises.
- (xxxv) The bidder is to sign and return the tender paper duly signed and sealed in token of their acceptance failing which the same may be ignored or rejected.
- (xxxvi) Tender should be in separate sealed cover super-scribed with “Tender against Tender Notice No.03/PAPER/ 2019-20”.
- a) First sealed cover will contain all tender documents including technical bid, EMD and Demand Draft towards Testing fees of sample(s), and excluding the rates of the items.**
- b) Second sealed cover super-scribed with price bid will contain the rates of the items.**
- (xxxvii) The tender along with sample should be furnished in the Office Chamber of the Accounts Officer (Purchase) of this Directorate on or before the last date and time specified for submission of tender. The sample received late shall not be accepted and bid shall not be considered.
- (xxxviii) Tenders sealed and super-scribed as above may also be sent by Registered Post addressed to the **Director, Directorate of Printing, Stationery & Publication, Odisha, Madhupatna, Cuttack-10** so as to reach him by the due date and time. Any tender even if posted on or before the due date fixed for submission of tender but reached beyond the due date and time will be liable for rejection.
- (xxxix) The tenders of the bidders / suppliers may not be taken into consideration, whose performance is not satisfactory during preceding years.
- (xl) For exact specification of different paper items, the successful bidder should consult with the concerned Unit Officers of this DPS & P Cuttack before supply of the paper items.
- (xli) All purchases shall be guided by the Finance Department O. M. No.4939/F., dated 13.2.2012 along with other Government orders issued from time to time.
- (xlii) Decision of the Director, Printing, Stationery & Publication, Odisha, Cuttack in regard to purchase of the articles stated in the Schedule above is final.

SPECIAL TERMS & CONDITION

In case of wrong information, forged document or manipulation if detected at any stage it shall result in disqualification of the tenderer to participate in the tender process. Besides above, the entire EMD shall be forfeited and the tenderer shall be blacklisted from participating in such tender process in future.
